This package is about changing the story for Kimberley communities—investing in safety, connection, and confidence. It takes a layered, evidence-informed approach, from early intervention and youth diversion to better lighting and CCTV. It draws on trauma-informed practice, justice reinvestment, and Crime Prevention Through Environmental Design (CPTED) principles to create safer, more connected places where people feel protected and proud to live.




### WHY WE NEED TO ACT

To unlock the social and economic potential of the Kimberley we need communities where residents and visitors feel safe, connected and can enjoy a good quality life. We need communities where businesses can attract and retain staff and have the confidence to invest, creating new jobs and driving economic growth. We need communities where trust is strong, creating strong social bonds and a sense of belonging.

Due to high rates of crime across the Kimberley, There is an opportunity cost to the community, many residents and visitors do not feel safe at not only through reduced access to services home, or at work or when travelling out and about facilities, but by funding for critical services and in the community. Businesses are closing and facilities being diverted in response to crime. residents are leaving. This is having a negative Local government expenditure due to crime is impact across the region, not only on the victims increasing. of crime but on the broader social and economic fabric of the community. For example, in 2022/23 the Shire of Broome

Kimberley local governments spend considerable time and resources addressing community safety initiatives. and crime prevention issues.

### WORKING TOGETHER FOR SAFER COMMUNITIES

The proposed Crime Prevention Investment Package has been shaped by deep community consultation, including police, businesses, service providers, and local residents. It contains a combination of on-off initiatives, which can be staged over several years and ongoing investment to support programs and/or public infrastructure costs.

#### THE PACKAGE BUILDS ON STRONG PARTNERSHIPS ACROSS THE KIMBERLEY AND BEYOND, INCLUDING:

- Local Government (Broome, Derby, Halls Creek, Wyndham-East Kimberley)
- WA Police and State Government agencies
- Aboriginal community-. controlled organisations
- Local businesses and residents

#### IT INCLUDES PROVEN METHODS SUCH AS:

- Criminogenic needs-based design
- Crime Prevention Through . Environmental Design (CPTED)
- Local service delivery partnerships .
- Justice reinvestment and youth diversion

Programs like the Broome Night Space, Halls Creek Youth Patrols, and Kununurra CCTV have already shown strong results. This package scales those efforts to all towns.



### PACKAGE **IMPLEMENTATION OUTCOMES**

#### This investment package aims to:

- Reduce crime and reoffending in Kimberley towns
- Improve public safety and community confidence .
- Support police through improved infrastructure ٠
- Provide youth with positive pathways and alternatives
- Create safer environments through CPTED design

The package aligns with and supports the goals of many State and Federal strategies from the WA Juvenile Justice Strategy to the National Crime Prevention, Target 120, Justice Reinvestment, and Closing the Gap. It complements KRG's own Position Papers on Community Safety and Juvenile Justice.
